MINUTES The Minutes of the October 8, 2018 meeting were approved as submitted.

BCCA ELECTION RESULTS. Silver Fork: Barbara Cameron, Tom Loken, Laynee Jones, Jenna Malone. Mt. Haven: Chris Pond. Forest Glen A: Jeanette Sawaya. Mill D North Fork: Doug Tharp. Don Despain served as election Judge.

UPD- Lee Arnold was welcomed back after recovering from a heart attack. He reminded everyone about snow restrictions in the canyon and chain up laws. Canyon Alerts will be posted on Facebook and twitter, please check for the most up to date announcements. UDOT is trying to get funds to hire a designated person to check vehicles for four-wheel drive and snow tires/chains before they enter the canyon. Lee reminded us that only one snow plow is available to work when it is snowing. The roundabout at Brighton is working out nicely and small traffic adjustments are still being made.

UFA - Cliff Burningham reported that Dusty Dern was away with Fires in California. Eleven crews were dispatched. Everyone is remembering Matt Burchett and sending well wishes to the teams working. We are thankful to the all teams and appreciate the experience they are bringing back to Utah. Cliff reminded everyone that most house fires are caused by cooking. Grease fires are the leading cause. Heating elements cause 19% of the deaths caused by fire. When turning your clock back also remember to check your batteries in your smoke detectors and carbon monoxide alarms.
Barbara thanked all the crews for their work on Chipper Days. A bid to complete chipper work in Cardiff came in at \$1000. BCCA was asked to contribute \$500 to share the cost with Utah Forests Fire and State Lands. A motion was made and 2nd to provide the funds. Motion passed. Barbara thanked Riley Pilgrim and the wildland crew.

CWC UPDATE-Ralph Becker addressed questions the BCCA members composed for the CWC. An updated proposal can be found on the CWC website for the most up to date information. Updates reflect comments and proposals they have received from the public. Mr. Becker addressed many of the questions concerning transportation, land exchanges, land management, budget, trail maintenance, and canyon restrooms. The town of Brighton can submit an application for membership once we become a town. Please check the website cwc.utah.gov for more up to date information.

SALT LAKE COUNTY. Rick Graham congratulated the community on the vote to become a town and offered SLC's continued support. The County Clerk will be working with the town of Brighton as we move forward in becoming a town. Ben McAdams is currently working on the 2019 budget that will be adopted by Dec. 11, 2018. Brighton is a part of the MSC general fund for UFA and UPD.

ACCT - Doug Fry reported the ACCT had two meeting since our last BCCA Meeting.

November 12th Meeting- Wasatch Canyons General Plan was discussed. The Plan has 5 main sections: Land Use, Environment, Recreation, Transportation and Economy. Tolls in the canyons were discussed and Jake is investigation how the toll revenues might be dispersed.

Pam Roberts from the Wasatch Front Waste and Recycling Department announced a recent satisfaction survey form 6,300 WFWRD customer 79.91% support continued recycling. She encourages all customers to learn and observe best practices for clean recyclable materials. Barbara reminded everyone "When in doubt- throw it out."

Clint Mecham, Battalion Chief, UFA, reported although there are fewer structures now than in 1980, the fires are deadlier because of higher percentage of petroleum-based materials. A home fire doubles in size every 40 seconds, which allow about four minutes to get our safely.

November 8th Meeting-Salt Lake County has identified 22,000 immigrants in the County who are eligible for Citizenship. Every County citizen counted in the Census is worth \$1,000 per year in Federal Funds returned to the County. The 2020 census will be done online.

UPD - Jason Marzuran, Chief of Police announced the formally combined Department, Magna and Kearns have now been split into two independent Departments, each with a new Chief Of Police. Canyon graffiti has recently increased and is rapidly becoming a

problem. Funding to address the issue has been received and a new prevention program will start in the spring one the snow cover is melted. Stronger penalties for offenders may include some jail time, clean-up of their graffiti and fines.

Brighton Town Update Carolyn Kiegley and Scotty Jones will set up a website where minutes of meetings will be posted. The timeline will also be posted on the website. We will have to elect a Mayor and four council members. Those interested in running for office must file by Dec. 21. Barbara encouraged everyone to get involved. Possible committees are being formed. Meeting notes for Nov. 11, 2018 were distributed to the council.

Resort News

Solitude- Kim Mayhew reminded everyone to be responsible when reporting news to the press. She ask that people be accurate and speak only with facts. Solitude works hard to deliver the highest quality of service and conduct business with the highest care for Big Cottonwood Canyon and its patrons. Solitude is hiring for the season and will open on Dec. 1.

Brighton- Randy Doyle reported they will be opening on Thursday and encouraged everyone to stay off the mountain until they open. The resort is concerned for everyone's safety, please do not enter the area until they officially open.
