UPD-Lee Arnold reported Revel Marathon will take place on 9/14th. Traffic will be escorted by eight different patrol cars up and down the canyon while the race is taking place. Over 4,000 runners have registered. Lee's team is doing their best to enforce the new no parking at the summit of Guardsman Pass. Traffic continues to increase in the Wasatch Front canyons, Millcreek logged 21,000 cars last week.

UFA-Dusty Dern reported that Chipper Days, will begin on September 9. Residents are asked to stack cut ends toward road in a clean row, and on the side of the main road or driveway. UFA does not offer private fuel mitigation. \$70k match grant is available for this canyon from the work received during Chipper days, and is used as in kind money for state. New hire test on the 8th, with approximately 250 applicants. Unifiedfire.org new web site and social media, check it out. New logos will be placed on all equipment. UFA is waiting on Brighton's official logo to be created. The fire up Emigration Canyon was 10 acres, and logged good response. Contained, all worked well with air crews, etc. 3 or 4 hours in had it all contained. Last winter, Peak Load Ambulance, look at response and call data and add when needed. Station 116, on Wasatch, was also ready to serve the resorts / canyons.

BUSINESS

SLCo Report – Rick Graham reported they are working with UFA and UPD on budget and finances for BCC and are drilling down to understand the exact cost of services. Mayor Wilson presents budget in October, will be set by mid-December. The big question is will Mayor Wilson fund from public fund at the same level for 2020 as it was for 2019. County council will vote on it. Mayor is committed to 2020, in a year the process begins anew. Fiscal year is calendar year. UFA and UPD run July 1 to June 30. Shouldn't make much difference. Will therefore fund UFA and UPD for 2020 and the first 6 months of 2021.

Conditional Use Permits- Jim Nakamura presented conditional use permits for SLCo, short term rental apps 1) Andrew Butler, at 12206 E Willow Loop Rd, Silver Lake Estates 4 bedrooms, adequate parking, on sewer, therefore checked. Signs must be posted on door or visible places about rules and regulations, including; hot tubs must be lock closed when not in use. 2) 6270 Rivers End Road, just off BCC road, 2 cabins with 2 parking places.

A motion was made on each proposal, seconded and passed with the condition that: 1) all homeowners bylaws are followed. 2) all hot tubes are locked shut when not in use 3) Garbage is stored in home or closed area and disposed of in dumpsters – paying attention to the proper disposal of trash in Bear Country. 4) BCC Short Term Rental Regulations are posted and followed. 6) No parking on roads that block the right of way or easement 7) maximum occupancy be honored. Residents in the canyon are encouraged to call UPD general dispatch if loud outdoor music or any disturbances.

Doug Tharp in Mill D reported significant water damage was done to the areas water tanks. Several gun shots were fired into the tanks. There has also been bear activity in the area and residents are discouraged from putting out bird feeders. Another report of a theft in Silver Lake area. All items in the house were taken.

CWC – Barbara Cameron reported USFS is restricting land swaps that involve land with mine tailings, tunnels, or twin ownership of surface and mineral rights. Land swaps that don't involve those issues can still proceed. The Cottonwood Canyons Transportation Action Plan (CCTAP) will also study Big Cottonwood Canyon. There was a HAWK meeting this morning. A recent traffic study warranted an overhead signal of some kind. UDOT suggested a HAWK. Law enforcement wants a red light so citations can be issued. Yellow flashing lights or lighted crosswalk aren't practical because no citations can be issued for yellow crosswalks. UDOT is re-looking at the plan in order to include an improved left turn lane into Cardiff South Fork. Lots of discussion about how that should be implemented. PATH study.

Election Judge Appointment -Jeannette Sawaya was appointed election judge for the BCCA elections. Jenna and Tom from Silver Fork are also on the committee.

Town Transition Team - The common goal is to secure regional county public safety funding for this regional recreation area, since the majority of the 2M day visitors to the canyon are county residents. (see http://www.bigcottonwood.org/town-of-brighton.html for more info.)
