Here are the major themes from community voices at the August 22, 2021 General Plan kick-off meeting. The majority of attendees were secondary homeowners, which indicates their significant voice in town governance. Thanks to everyone who came or filled out the on-line survey.

- Make permitting processes more understandable to property owners.
- Reduce impacts of noise and light pollution
- Address natural disaster risk (fire, avalanche, floods, etc.)
- Expand opportunities for all community members and stakeholders to get involved in decisionmaking processes.
- Pursue traffic safety improvements, particularly to address bicyclists in the Canyon
- Consider impacts of taxing structure on fixed and low-income property owners.
- Expand multi-modal transportation options and consistency of service.
- Beautify Town infrastructure
- Act as stewards of the pristine Canyon ecosystem and abundant natural resources.
- Maintain a rich social network and community feel.
- Enhance community amenities and add places for social gathering.
- Preserve community design characteristics
- Improve trail infrastructure to better address impacts of visitors.



The Annual Revel Marathon will return to Big Cottonwood on Saturday, September 11, 2021 after last year's COVID recess. There will be rolling closures of the highway between 6-11 am. # CAMPFIRES IN BIG COTTONWOOD CANYON

A Conversation with Guy Wilson, USFS Fuels Specialist

# Q: Why are campfires being allowed in Forest Service Campgrounds when fire danger is so high?

A: Camp areas have established concrete pads surrounded by dirt, metal fire rings, water availability and we continually maintain the vegetation to a safe distance. Should unsafe short term weather conditions materialize the camp host can notify campers and monitor the area quickly. We evaluate fire risks daily based on current and expected weather forecasts and are coordinating with the State and County fire agencies to change any restrictions as close to the same timeframe as possible to reduce confusion. Q: Brighton moved to stage 2 (no open campfires in town) in June. There is concern from residents that fires in campgrounds send mixed messages to short term rental vacationers that fires are OK. Also some are concerned about the proximity of their homes to campgrounds if a spark were to fly.

A: These sparks or embers lofted generally are small in size and don't travel past established barriers and can't maintain enough heat past these barriers to generate a fire. Camp areas have established concrete pits or rings, and brush is well maintained, plus watchful campground attendants can notify campers quickly if a fire is too large, and or in the event of short term unsafe weather conditions in campgrounds. We continually worked hard to create and maintain shaded fuel breaks around the campgrounds to make them fire resistant for the surrounding forests and communities, yet attractive with no clear-cutting. Our priority is to maintain a healthy and fire resistant ecosystem that benefits all.

# Q: Brighton no longer allows outdoor campfires for short-term rentals. Is that a good idea?

**A:** That's up to the Town Council. But, consistency is always helpful. It's difficult for us to go out of restrictions for a week or a few days, then have to go right back in. In our case, we also don't want to make one canyon different than the other.

#### Q: Have the recent rains made any difference?

A: We evaluate our fuel conditions daily but take physical samples bi weekly to verify the actual moisture content of fine and heavy fuels. I thought you would be interested to know the results of our 3<sup>rd</sup> week of August fuel samples. We saw a noticeable rise in fuel moisture content from the recent rains in our fine fuels and a more average (for this time of year) fuel moisture content in our heavy fuels. So fire restrictions ended on September 2nd at 0001 hrs. on all Uinta Wasatch Cache N.F. lands. However we will continue to evaluate these conditions weekly and monitor the long term forecast should we need to resume restrictions.

#### Q: What can we do to help you mitigate wildfire in Brighton?

A: We have been working actively with the Town of Brighton and the UFA on the Fuels Mitigation Project. To sign up see this link: <u>FUEL\_MITIGATION\_PROJECT.pdf</u> (<u>registeredsite.com</u>). Also the annual Chipper Days to create Defensible Space has helped. USFS is encouraging homeowners to use Chipper Days for fuel reduction on any USFS property that is 150 ft. from their home. #### Stay Aware of Watches and Warnings.

GENERAL WARNINGS: Make plans and consider moving persons with mobility or medical issues. Please use common sense and evacuate at any time you feel uncomfortable or see active fire behavior.

**EVACUATION WARNING:** A wildfire threat is in your area. It would be wise to consider planning and/or packing, in the event an evacuation becomes necessary.

Remember the 6- P's:

- 1. Plan for the persons in your family (including a meeting place.)
- 2. Personal items (including toiletries, food and water for 2-3 days and special personal possessions.)
- 3. Prescriptions- Have your full, current supply of prescriptions packed.
- 4. Photographs (and other mementos) which cannot be replaced.
- 5. Pets (Have a plan in place and pets secured so frightened pets don't escape fenced yards or kennels.)
- 6. Papers- Pack all important papers, including reference phone numbers, account numbers, etc.

MANDATORY EVACUATION ORDER: Occupants of the affected area(s) are asked to leave within a specified time period, by pre-designated route(s). Perimeter roadblocks are typically established. At this stage:

- A You should take your family, pets, and necessary items including medications and important papers and evacuate now if you are in a Level III area.
- ♣ Check in with your local neighborhood team to let them know where you will be in case your family is looking for you.
- A Drive with your lights on, safely and SLOWLY remaining aware of your surroundings as you leave.

# Tales of the Wasatch presented by the Biz Cottonwood Canyon Historical Society

# GILES FLAT AND THE JOY OF MOUNTAIN MUSIC

Giles Flat was named for Hyrum Lorenzo Giles who was born in Nanty-glo, South Wales in 1850. His father, Thomas, was a collier (coal miner) until a large piece of coal hit him in the head and knocked out both his eyes in the summer of 1848. Soon after, he became known as the "Blind Harpist" for his fine musical talent.

In 1856 the family crossed the ocean in a ship, and then this country in a handcart. Little 6 year-old Hyrum's feet and legs were almost amputated because of frostbite when he arrived in the Salt Lake Valley. His mother and sister had died in the bitter cold. He told of how they were so hungry that they boiled the leather from boots and tires to get a warm gelatin drink that kept them going.



Thomas Giles and his son were reunited in Salt Lake where little Hyrum learned to sing, dance and play the violin. Soon the Blind

Harpist and his son became well-known throughout the area, traveling from town to town to play for dances that sometimes lasted all night long. Children spent the night bedded down near the dance floor. People brought money and food to pay the musicians, who were rather prosperous in those days. Hyrum met his wife, Minnie, at Park City while playing for a dance. When he saw her, he stepped off the bandstand right onto the dance floor, proclaiming, "This is the girl I'm going to marry." And he did.

It was silver and gold, however that made Hyrum a rich man. He homesteaded over 600 acres of land at the top of the canyon. He was the owner with Tom Kearns of the Silver King Mines in Park City, and owned the Giles Mining and Milling Company in Big Cottonwood. His land had 6 or 7 log cabins on it. Solitude Mountain Resort occupies this land today. Hyrum's joyful spirit lives on in the recreation opportunities and celebrations that happen at Solitude year-round.
