**UPD REPORT** Detective Cheryl Lenzer • The last month of the year was a mild one for us, but it looks like winter has arrived now. There were 219 total calls for the canyon last month compared to the 620 calls in Dec. 2022. There were 23 Traffic Enforcement calls, 12 Traffic Accidents, 6 -Camping in a Watershed, 3- Dogs in a Watershed, 7- Canyon vehicle assists, 1- Impound, 3- Citizen assists,1- Welfare Check, 1-Search and Rescue, 1- non -criminal domestic, 1- Fraud at Brighton Resort and 11- Ski Thefts at Brighton Resort. There were also a few Skier Collision calls at both resorts. One of those had been featured in the news. We are looking for any information in the identity of the other skier involved that caused the injuries.

Last month was the first month UPD has been able to issue Parking Notices in the rest of Big Cottonwood Canyon. These notices have the same fee schedule as the Town of Brighton has. So far only a few have been written in the lower canyon area. We anticipate this to help the parking issues we see in the summer around the S-Turn. There were 120 Parking Notices written in the canyon last month as well as 46 traffic citations. We are starting to see an improvement with the new reservation system with the flow of traffic into the canyon in the morning, however once the resorts are closed for the night we do see the regular heavy flow (or red snake) of cars exiting at the same time. I can't say if the new reservation system helps with the parking issues yet as we haven't seen a lot of snow. The storm this past weekend and the ones line up for this weekend there may be issues.

### INCOME

\$8,300 from the Town of Brighton for administrative and project purposes.

### **FUNDED PROJECTS**

- \$2,500 to the Cottonwood Canyons Foundation to Adopt the Butler Fork Trail.
- \$2,288.56 for 4<sup>th</sup> of July Expenses
- \$339.00 Administrative Expenses

### SERVICE PROJECTS

- 4th of July Breakfast and Parade. Cost \$2,380.62. 450 people were served breakfast, with many more in the parade (Thanks Kim Doyle, Carolyn Keigley, Bryan Luftglass, Kathy Anderson, Doug Fry, Todd Nerney, Sarah Cookler, Mike Doyle, Dan Knopp, Kara John, Lisa Sommer, UFA and UPD!)
- Chipper Days. 107 families signed up for Chipper Days, representing 1,438 hours contributed by local homeowners for a value of \$39,545. Those hours will be used as in-kind match for next year's grant (1,438 hrs. x \$27.50 volunteer hour value). Thanks to Jane Martain for wrangling this project.
- Adopt-A-Highway The 36<sup>th</sup> year of this project was coordinated by Tom Loken.
- Fuels Reduction Project. 105 families are enlisted for the Fuels Reduction Project being run by UFA. Crew members visit with homeowners to decide which trees and brush need attention, and then they perform the work on-site. 37 properties were completed in 2022, 11 properties were completed in 2023, 57 properties remain. All families commented about the outstanding work done by UFA.
- **Weed Mitigation Projects.** BCCA members participated in noxious weed pulling and wildflower planting projects under the leadership of Taylor Litwin from Cottonwood Canyons Foundation.

### 2024 GOALS & SUGGESTIONS

- Continue Fuel Mitigation projects (Chipper Days and Fuel Reduction Project).
- Advocate for buried electric lines in canyon communities.
- Promote improved fiber and internet connections.
- Encourage the installation of a new Restroom at Willow Heights Trailhead.
- Continue to support USFS Trails Master Plan for Natural Surface Trails in the canyon.
