#### **EXECUTIVE SUMMARY**

- 180 days/year are the maximum rental days being allowed.
- 2 day-minimum rental is required.
- All STRs must have year-round approved water and sewer connections.
- Each Short Term Rental must have a business license from the MSD (cost is \$150/year).
- Umbrella licenses are available for STR property managers (cost is \$500/year, plus \$50/unit).
- Responsible host must be able to respond to complaints/questions within 20 minutes and be able to be on site within 2 hours if needed.
- STRs must comply with general community ordinances such as noise (quiet hours are 10 pm-7 am), parking, campfires, snow tire requirements, dogs, trash, and roof avalanche warnings.

The Town Clerk will keep track of all comments and update them on the Town website. Thanks for your help with this important issue for the Town of Brighton.

## **NEWS & NOTES**

**Break the Berm.** UDOT has asked homeowners to be aware that the big snowplows cannot lift the plow blades as they pass by canyon driveways and roads. It's State law that property owners are responsible to clear their driveways after a plow has passed by. Most residents expect this on snowy days and go out to break the berm



before it freezes into an iceberg. There have been quite a few complaints to UDOT lately, so please let newcomers know about plowing their own driveways. Afterall, the big plows give us an awesome and reliable road to civilization.

**Avalanche.** Jake Brown, our hard-working UDOT Road Maintenance Supervisor, was clearing the road from multiple avalanches in Little Cottonwood on February 7, when he was caught in an avalanche himself. An avalanche near the Seven Corners area (which hasn't slid for many years) surprised him and a grader operator. Both dug themselves out, but had to hike over seven other slide paths to get help. With no injuries, they feel lucky to be able to tell the story.

Catalytic Converter Thefts. A local Silver Fork resident reports that his truck's catalytic converter was stolen while it was parked at upper Guardsmans Pass Road. He returned after a few ski runs, and knew something was wrong when his engine sounded like a chopped outboard motor. A quick look under the truck showed half the exhaust system was missing. His mechanic charged him \$600 for a replacement, saying thieves sell the catalytic converters as scrap metal (platinum included) for about \$200. Canyon Patrol officers say they have seen several Catalytic Converter Thefts in the canyon recently. UPD officers ask us to report this kind of activity to them (801) 743.7000.

### TRAILS UPDATE

This month, the Trails Committee got an amazing note from Zinna Wilson, USFS Trails Manager. It helps start a collaboration with Salt Lake County and USFS. It goes like this: The Salt Lake Ranger District (SLRD) Trails Program would certainly benefit from a Countyled master-planning effort. The best arrangement would be for Salt Lake County to serve as the umbrella for a cross-jurisdiction plan, and the Forest Service to lead the planning effort for Forest lands.

Salt Lake County is the umbrella organization for a trail plan.

- The area of consideration could focus on the tri-canyon area, or encompass something broader.
- County leadership allows for multiple jursdictions to come together and plan across property boundaries.
- County has capacity for better mapping, surveying and public involvement than does the Salt Lake RD.
- Recent County planning efforts highlighted the need for a County trails masterplan.

SLRD provides Salt Lake County with the plan for Forest land, and participates in cross-jurisdiction planning.

- We assess current conditions of system trails, user trails, trailheads, recreation opportunities, and resource conditions
- We refer to stakeholders groups, Forest Plan, County research, etc to understand values and desired future conditions
- We propose alterations to the existing trail infrastructure and management that address those values and needs
- We'll need an employee dedicated exclusively to interfacing with the SLCo planners—we currently have an exceptional employee in place and hope to keep her inventorying, planning, and collaborating.
- This FS planning is essential to our program, we'll pursue it internally even if Salt Lake County opts-out of planning.

### As for funding...

- Both the County and the SLRD will need funds to make this happen; County will need more than SLRD.
- If Salt Lake County is able to secure funds and transfer some to the FS, excellent!
- If Salt Lake County can only secure funds for their own branch of the collaboration, the Salt Lake Ranger District will need to find a funding source.
- We have gotten grants for some of the initial inventory of user trails and system trails, but not yet for other resource surveys, needs assessments, or planning efforts.
- We support the County pursuing funding to create a trails masterplan for the Central Wasatch. What further steps do you recommend we take to convey this support, and ideally to secure enough funding for a Forest Service employee dedicated to interfacing with the County?

MINUTES The Meeting Minutes of January 18, 2021 were approved as submitted.

### **REPORTS**

**UPD** - Officer Lee Arnold reported that Canyon Patrol has a new Sergeant, Mike Hill, and a new Deputy, Taylor Rauch. Another scam is moving through the canyons. Scammers are able to detect the presence of equipment that's transmitting wi-fi signals. If you leave a phone or iPad in the car, it could be stolen in a break-in, so be sure it is turned all the way off. The Canyon continues to be very crowded and Big Cottonwood Canyon has been shut down because of snowstorms. UPD is doing their best to control traffic flow. Burglaries are down, except for burglaries at the resorts involving ski equipment.

### **BUSINESS**

**Municipal Services District (MSD)** – Barbara read a report from County Liaison Jocelyn Romero, that requested ideas for infrastructure funding projects for 2022. Some of the ideas presented include:

- Burying electric lines in the canyon
- Cardiff Restroom-new water pump system
- Mill B Restroom-new water pump system
- Mill B Parking Lot- plow to keep the trailhead open in winter
- Mill B Pedestrian Tunnel

- Trails Master Plan for Natural Surface Trails
- Trail upgrade from Solitude to Fire Station
- Twin Lakes Dam Trail maintenance

Mountainous Planning District (MPD) Update – Barbara reported that the County Council took the following actions at their February 9, 2021 Meeting: The Council instructed its Lobbying Team to advocate for (1) Removing the Town of Brighton from the MPD and the MPD Planning Commission so that it may have its own land use authority; (2) Removing the sunset provision as it relates to Utah Code 17-34-1(5)(d), or draft new legislation allowing the County to use its General Funds for fire, paramedic, and police protection services under certain circumstances as currently granted in Utah Code 17-34-1(5)(d); (3) Removing the sunset provision from the Mountainous Planning District and Mountainous Planning Commission; and (4) Allowing the County to determine the membership, terms of service, and duties specified by County ordinance, similar to the criteria in Utah Code 17-27a-301(3). This Resolution was passed unanimously by County Council members.

An additional legislative rider was requested by Councilmember Aimee Winder Newton: The Salt Lake County Council instructs staff to write an ordinance regarding the Mountainous Planning District. This ordinance would include that the Mountainous Planning Commission shall be comprised of commissioners from the following areas:

- One commissioner each who resides in Sandy City, Millcreek, Cottonwood Heights City, and Salt Lake City (for a total of four);
- One commissioner who resides in a municipality located west of Interstate 15;
- Two commissioners who reside in any of the Mountainous Planning District, the Town of Brighton or the Town of Alta;
- Two regular commissioners and two alternate commissioners who reside anywhere in the incorporated or unincorporated Salt Lake County.

This appointment process would be done by the county mayor with advice and consent by the county council. A Bill file has been opened by Senator Bramble, but it hasn't been numbered yet. The decision will before March 5, 2021.

**Short Term Rental Update.** The Brighton Town Council is working on the short term rental ordinances. Details and information can be found at <a href="https://www.brighton.utah.gov/">https://www.brighton.utah.gov/</a>. Short Term Rentals must have a business license and are restricted to 180 nights/year. They have hired Granicus, a private agency to do a hotline for complaints. The only communities that are eligible for short-term rentals are Brighton (159 cabins) and Silver Fork (179 cabins). That's a total of 339 cabins out of 567 cabins in the Town of Brighton. Other canyon communities are not allowed to have short-term rentals because they don't have year-round sewer/water. The MRZ (Mountain Resort Zones such as Solitude and Brighton) are not included in this number, because MRZ areas are allowed to have short-term rentals. A public meeting will be held before any final decision is made.

**Trails-** John Knoblock reported trail projects received \$20,000 from BCCA for the reroute of the Willow Heights Trail. Future projects include two bridges on the Willow Creek Trail in the summer of 2021. Also in the pipeline is finishing the eastern end of Desolation Trail and finishing the bridge at Cardiff.

#### **Resort Updates**

**Solitude** – Kim Mayhew expressed gratitude for backcountry avalanche teams that helped with the tragic Millcreek avalanche. She said to warn family and friends of the absolutely scary risks out there right now. Restaurants are still closed, but that's been helpful to control the spread of Covid. Both resorts report that no employees have gotten Covid traced to employment at the resorts. Masks and distancing are important for staying open.

**Brighton** – Randy also commended the Wasatch Back Country Rescue teams for their work with the Millcreek avalanche. It was a very sad weekend. They are using a semaphore sign system to keep people off the slopes during control work, and encouraged everyone to observe the red/green sign. Both resorts said the Resident Passes were working well.
